



Under its Prevention Education program component, ERC provides life coaching and skill building programs and services across six public health districts in Georgia. During 2010, ERC conducted 173 HIV and sexually transmitted infection (STI) prevention workshops and teenage pregnancy prevention programs for medically and economically disadvantaged clients with high-risk behaviors. ERC has several programs, such as Project Aware, Reproductive Health Initiative, and Condom Dealin' Skillz, using the VOICES and SIHLE behavioral interventions. A total of 968 unduplicated participants attended these sessions and 900 safer sex kits were directly distributed in community settings, such as homeless shelters, transitional housing programs, mental health facilities, substance abuse outpatient facilities, job readiness programs, correctional facilities, foster homes, alternative schools, Boys & Girls Clubs, recreational centers, and at health fairs. ERC also offers capacity building programs that provide professional development and training opportunities for staff, volunteers, and other non-profit organizations, expand community resources, and establish solid foundations from which to address reproductive health-related disparities.

4b (Code:) (Expenses \$ 65,466. including grants of \$ 0.) (Revenue \$ 0.)
Under its Counseling, Testing, and Referral (CTR) services component, ERC provided HIV, Chlamydia, and Gonorrhea counseling and testing services and STI treatment services to 185 clients. ERC administers testing through its Comprehensive Intervention Clinic, using the OraQuick rapid HIV test kits, OraSure HIV confirmatory test, and Aptima Combo Assay specimen collection devices. Of that amount, 2.2% of clients were HIV infected and linked to primary care services through Ryan White Clinics. ERC served individuals residing in Fulton, DeKalb, Cobb, Douglas, Henry, Gwinnett, Clayton, Rockdale, Newton, Cherokee, Paulding, Muscogee, Richmond, Fayette, Jasper, and Chatham counties. In-kind donations of toiletries, condoms, literature, and test kits, in addition to purchased items, were distributed to clients as part of their safer sex kits. The vast majority of support for this component was provided by volunteers.

Under its Support Services program component, ERC provides health advocacy and community outreach campaigns for high-risk clients, and linkages to case management and primary care for HIV positive clients. ERC use the ARTAS Linkage to Case Management (ALCM) evidence-based intervention. During 2010, four (4) HIV infected clients were served through this volunteer supported program.
