Our Mission

ERC is a comprehensive HIV and STI community-based organization that offers HIV and STI prevention education, risk reduction counseling, testing, referral and treatment services, client advocacy and navigation services, and primary care linkages. Our mission is to directly deliver health-related programs and services and generate solutions to community issues that impact the transmission HIV and other STIs.

### **Our Model**

It can be very difficult to access and navigate the health care system. We provide programs and services on-site at our Comprehensive Intervention Clinic, at satellite locations, and through the ERC on the M.O.V.E. community outreach program. ERC focuses on a broader array of services, assisting both individuals infected and affected by HIV and other STIs.

### **Our Clients**

In 2014, we served over 600 clients and reached approximately 80% of our clients through the ERC on the M.O.V.E. We serve some of the city's most marginalized and disenfranchised individuals. 44.3% have a history of incarceration, 62.6% have a history of substance abuse, 23.6% present with mental health challenges, and 90.4% report having sexual activities with someone of unknown status. See the included graphs for our client population.

### HIGHLIGHTS & ACCOMPLISHMENTS

With the support of its partners and contributors, Empowerment Resource Center was able to able to substantially progress toward fulfilling its mission during fiscal year 2013-2014. Over the last year, we are pleased to report the following accomplishments:

- During this past fiscal year, Empowerment Resource Center Based on client needs, ERC incorporated oral and rectal swab testing for Chlamydia & Gonorrhea into our repertoire of services.
- During the past fiscal year, Empowerment Resource center administered over 800 clinical services to 663 distinct clients
- The Department of Public Health Grant funded Programs for Positives (P4P) Peer Educator Certification Program, which aims to provide experienced people living HIV/Aids with the necessary skills and resources to help newly diagnosed HIV Positive clients find and maintain care.
- ERC Developed the ICP Behavioral Health program which administers mental health counseling and substance abuse treatment ERC's clients.

#### **Other Noteworthy Accomplishments**

- Hired two Community Outreach Health Educators to overcome cultural and socio-economic barriers that affect the majority of our clients.
- Provided free HIV and Syphilis screening services and other healthrelated resources to over 1,000 participants during the ERC 7<sup>th</sup> Annual Take Charge. Get Tested. Event.
- Hosted the inaugural Exploring Realistic Expectations Symposium which aims to engage health professionals in an interactive, informative, and more accurate discussion about TaSP, PrEP, and non-occupational PEP
- Hosted <sup>3rd</sup> Annual Hats Off to Women in observance of National Women & Girls HIV/AIDS Awareness Day.



# Clinic Expands STI Screening Services

Empowerment Resource Center's Comprehensive Intervention Clinic has added additional swabbing options for Chlamydia and Gonorrhea to our repertoire of services. The incorporation of oral and rectal Gonorrhea/Chlamydia screenings allows ERC to diagnose and treat clients in areas that were previously inaccessible to testing, but susceptible to infection. We are happy to provide our diverse and evergrowing group of clients with screenings in these areas that are important, but, unfortunately, are frequently neglected.

In addition to expanding Chlamydia and Gonorrhea screening methods, ERC also sought to increase Hepatitis C awareness through its Hepatitis T.A.P. Outreach Campaign by providing condoms, literature, and free and/or discounted HCV testing throughout the month of May.



Testing Services Administered During 2014

\*Women's Wellness includes Bacterial Vaginosis, Vulvovagival Candiasis & Trichomonas

During 2014, ERC's Comprehensive Intervention Clinic screened a total of 145 unduplicated clients and of those unduplicated clients 49 tested positive for at least one STI. 88% of those clients who tested positive for an STI chose to return to our clinic for treatment while the other seven percent were referred to outside health agencies.

### Who We Are

Since 2003, the Empowerment Resource Center's priority has been to serve individuals who are underserved and high-risk. We strive to create a safe, welcoming environment where our clients can access sexual health services. We value and adhere to our mission to deliver health-related programs and services and generate solutions community issues to that impact the transmission of HIV and other sexually transmitted infections (STI).



# Integrated Care Partnership of Metro Atlanta


Due to the funding provided by SAMHSA, Empowerment resource center was able to develop the Integrated Care Partnership of Metro Atlanta (ICP) Behavioral Health Program. The ICP program strives to provide clinical and behavioral health services to individuals who are concurrently battling mental and substance abuse disorders. Clients who are enrolled in the ICP program meet frequently with ERC health educators who educate and assess their knowledge of sexually transmitted infections, as well as provide access to HIV, Hepatitis B, and Hepatitis C testing and screening services.



The development of the ICP program allows Empowerment Resource Center to extend our care not only to those individuals who seek sex based services but also to the large population of people who have mental and substance abuse disorders.

### Who We Serve

We provide services to men and women ages 13 and older who live in the southeast region of the United States. Our clients come from all walks of life; in 2014 66% were screened in an outreach setting, 82% were homeless, 80% reported having no insurance, and 58.8% have had an STI at some point.



# **2014 Special Events**

#### 3<sup>rd</sup> Annual Hats Off To Women Symposium

#### March 10th was National Women & Girls HIV/AIDS

**Awareness Day**. In honor of this day, the Empowerment Resource Center hosted the Hats Off to Women Symposium to increase the awareness of the specific impact of HIV and AIDS on women and girls. #### Inaugural Annual Exploring Realistic Expectations Symposium

Over the course of two days, Empowerment Resource Center hosted its Annual Realistic Expectations Symposium where health professionals gathered to discuss the benefits and effectiveness of biomedical interventions such as PreP, PEP, and TasP as preventative measures and treatment of HIV and other sexually transmitted infections.

On June 27, 2014, ERC held a free HIV testing campaign and is expected to reach more than 500 Atlantans! This open fair and festival was held at Hurt Park, located at 100 Edgewood Avenue, SE in Atlanta GA. This community outreach campaign provided free HIV and counseling and testing services, primary care linkages, and other health-related programs to approximately 1,500 individuals.
