ERC is a comprehensive HIV and STI community-based organization that offers HIV and STI prevention education, risk reduction counseling, testing, referral and treatment services, client advocacy and navigation services, and primary care linkages. Our mission is to directly deliver health-related programs and services and generate solutions to community issues that impact the transmission HIV & other STI's

#### **Our Model**

It can be very difficult to access and navigate the health care system. We provide programs and services on-site at our Comprehensive Intervention Clinic, at satellite locations, and through the ERC on the M.O.V.E. community outreach program. ERC focuses on a broader array of services, assisting both individuals infected and affected by HIV and other STIs.

### **Highlights & Accomplishments**

Thanks to the generous support from our funders, Empowerment Resource Center was able to tackle many amazing feats this year. Here are some of our Highlights and Accomplishments.

- In March of 2016, the Behavioral Health and Outreach Services (BHOS) Center was unveiled! The BHOS has successfully expanded ERC's capacity to provide individual and group-level interventions to our clients
- Became licensed as a Drug Abuse Treatment and Education Program by the Georgia Department of Community Health
- ERC received the SAMSHA Syringe Services Program Grant for substance abuse treatment with intravenous drug users.
- Behavioral Health services were expanded from eight weeks to six months
- In-kind psychiatric services and psychotropic management were incorporated into our repertoire of behavioral health services
- The new ERC website was launched!



### It's Complicated: LGBTQIA Support Group

In 2016, ERC launched *It's Complicated*, which is a support group that aims to help young gay/bisexual men and transgender women navigate their way through a world were social and societal norms are often not in their favor. Each Friday night ERC staff members and members of the support group gather to engage in an open dialogue about the various experiences they have endured that week.

### **Mind Over Matter Project**


The Mind Over Matter Project is a subset of ERC's ICP program that is aimed at increasing awareness of mental health issues as well as removing the social stigma that surrounds behavioral health disorders and the people who have them.

### **Comprehensive Intervention Clinic Updates**

This year, the Comprehensive Intervention Clinic (CIC) incorporated Trichomonas testing for men into its extensive repertoire of services. In conjunction with the expansion testing services, the CIC began offering Pre-Exposure Prophylaxis (PrEP) to high risk clients as a method HIV prevention



**5th Annual Hats Off to Women Symposium** On March 10, 2016, ERC hosted its 5th annual Hats OFF to Women Symposium. In observance of National Women and Girls HIV/Aids awareness Day. The *Hats Off to Women Soirée* focuses on HIV prevention, transmission modes, and barriers to HIV prevention in efforts to dispel misconceptions and increase the likelihood of reducing at-risk behaviors.



### 9th Annual Take Charge Get Tested Event™

Each year on June 29, Empowerment Resource Center hosts its Take Charge Get Tested event at Hurt Park in Atlanta, Ga where over 1,000 HIV tests are given to members of the community in order to encourage them to be in charge of their health.

Over the course of two days, ERC hosted its biennial *Exploring Realistic Expectations Symposium* where various members of the public health field gather to discuss new and innovative ways to prevent the spread of STI's.
